Battery Cover & On/Off Switch:

Turn ON by twisting counterclockwise. Turn OFF by twisting clockwise. Change the battery by twisting on counterclockwise and continue turning past the ON position until bottom is removed. Insert one AA battery with the positive (+) pole facing the bottom of the unit.



Replace battery cover by aligning threads and turning clockwise.

Caution: Do not submerge in water or allow water to enter the battery compartment.
